1. This opportunity is only available for students whose parent/legal guardians receive electricity from Agralite Electric Cooperative. The Rural Electric Youth Tour is a benefit of co-op membership.
2. Must be a high school sophomore or junior during the 2025 school year.
3. Must be available to participate in the dates and full schedule of the Youth Tour in Washington, D.C., which is June 16-21, 2025.
4. Must be able to ride in a vehicle or bus for up to 12 hours (with breaks) in a single day.
5. Must be able to fly in an airplane and provide a valid Minnesota driver's license or Minnesota state-issued ID card.
6. Must agree to be photographed while on the Youth Tour, and must grant permission for cooperative use in publications, social media, websites, media, etc.
7. Applicant may be invited to present at the Agralite Electric Cooperative Annual Meeting to recap their Youth Tour experiences and gained knowledge of electric cooperatives.
