### Energy Saving Tip:

Taking steps to help your home heating system run more efficiently can reduce energy use and lower winter bills. Check to see if any air vents around your home are blocked by furniture, curtains, or other items. Obstructed vents force your heating system to work harder than necessary and can increase pressure in the ductwork, causing cracks and leaks to form. If necessary, consider purchasing a vent extender, which can be placed over a vent to redirect air flow from underneath furniture or other obstructions.

### New Year's Resolution: Be Energy Efficient Year-Round

#### Seal in comfort and savings

As energy consumers, we can all play a part in conserving resources and reducing our bills. Here are some practical tips to boost your home's energy efficiency throughout the year:

#### Know your energy consumption

Start by reviewing your energy bills for the past 12–24 months. Calculate your average monthly usage to establish a baseline for measuring your energy-saving efforts.

#### Adopt no-cost ways to save energy

Small changes can lead to significant savings:

- Turn off lights and unplug electronics such as chargers when not in use.
- Close or lower window coverings to regulate the temperature indoors.
  - Change your air filters regularly as recommended.
  - Use ceiling fans strategically: counterclockwise in summer and clockwise in winter to force warm air down.
  - Grill outdoors in summer to keep the heat out of the kitchen.

#### Insulate your home

Weatherproofing is key to maintaining comfort and reducing energy use:

- Check for air leaks around windows and doors using the wet finger or tissue test.
- Apply caulk or weatherstripping to prevent drafts.
- Remember to keep doors closed to maintain indoor temperature.

#### Get smart with your thermostat

Optimize your heating and cooling by using your programmable thermostat's features many homeowners never use them—and allow it to adjust the temperature when you're asleep or away.

- Consider upgrading to a smart thermostat for automatic adjustments
- In general, adjust the thermostat a few degrees up or down for energy savings.

#### Explore renewable energy

Consider harnessing the power of natural energy sources:

- Look into installing solar energy panels for your home.
- Research local community solar programs that may be available.

#### Consult your electricity provider early in the process. They can provide valuable information about:

- Grid connection requirements.
- Cost considerations.
- Potential rebates are available for renewable energy installations.

Always call your utility company at the number provided on your bill or on the utility's website if you have a question about payment or billing information. Know your utility bill payment options—online, by phone, automatic bank draft, mail or in person.

#### 2025 Agralite Scholarships

# COLD WEATHER RULE & ENERGY ASSISTANCE PROGRAM NOTICE

In accordance with Minnesota's Cold Weather Rule, electric service cannot be disconnected for nonpayment between October 1 and April 30 if electricity is the primary heat source and ALL of the following statements apply:

- Your household income is at or below 50% of the state median household income. Income may be verified on forms provided by Agralite Electric Cooperative or by the local energy assistance provider.
- You enter into and make reasonably timely payments under a payment agreement that considers the financial resources of the household.
- You receive referrals to energy assistance, weatherization, conservation, or other programs likely to reduce your energy bills from Agralite Electric Cooperative.

#### Minnesota's Cold Weather Rule does not completely stop winter disconnects

Before disconnecting electric service to residential members between October 1 and April 30, Agralite Electric Cooperative must provide:

- A 30-day notice of disconnection;
- A statement of members' rights and responsibilities;
- A list of local energy assistance providers;
- Forms on which to request Cold Weather Rule protection; and
- A statement explaining available payment plans and other options to continue service.

#### **Energy Assistance Program**

The Energy Assistance Program (EAP) is a federally funded program through the U.S. Department of Health and Human Services, which helps low-income renters and homeowners pay for home heating costs and furnace repairs. Household income must be at or below 50% of the state median income (\$58,793 for a family of four) to qualify for benefits. Applications must be received or postmarked by May 31, 2025.

### **2025 Basin Scholarship** Qualify? Please Apply!

Basin Electric Power Cooperative, a wholesale power supplier to Agralite, is again offering this generous scholarship. Basin Electric's scholarship program began in 1990. Each year, Agralite solicits scholarship applications throughout our service area.

#### How Much Is The Scholarship?

The Basin Electric Power Cooperative (BEPC) Scholarship Program will award more than 180 scholarships. Agralite will award one \$1.000 scholarship. The scholarship must be used for educational costs, and the student must enter college in the fall of the school year for which the scholarship is given. Checks will be made payable to the school, and will be distributed to the school by BEPC. Scholarships will be distributed in August.

# Who Is Eligible To Receive The Scholarship?

Dependent children (including adopted or step-children) of member-system consumers and dependent children of membercooperative employees are eligible. The applicant must also be a U.S. citizen and enrolled or planning to enroll in a full-time undergraduate course of study at an accredited, two-year or four-year college, university or vocational/technical school. Recipients are selected on the basis of academic record. potential to succeed, leadership, and participation in school and community activities, honors, work experience, a statement of education and career goals, and an outside appraisal.

#### How Do I Apply?

Obtain forms and applications from your school counselor, the Agralite Electric Cooperative office, or www.agralite.coop.

The Operation Round Up Trust Board met on November 21st to review grant applications received. They reviewed and considered nine grant applications and a total of \$14,800 was distributed to eight of them.

Operation Round Up is a program made possible by Agralite Electric Cooperative members who round up their monthly electric bill to the next dollar. The average donation of each participating Agralite member is less than \$6 annually. The extra cents go directly into a trust that is administered in g rants to community organizations. #### Load Control Notifications

Due to our current load control notification system no longer being supported, we are switching to notifications through SmartHub. To manage or receive load control notifications from Agralite Electric Cooperative, you will now need a SmartHub account.

#### How to Set Up Load Control Notifications

Visit www.agralite.coop, click on Pay Bill, and sign in (or create an account). If you haven't previously signed up for any notifications, you will need to take the following two steps:

- 1. Add Contacts: Under the Settings drop down menu, select Contact Methods. Add an email contact and/or a phone contact\*. Follow directions and enter the verification code where appropriate. You can set up as many as you'd like.
- Set Up Notifications: Under the Settings drop down menu, select Manage Notifications. Select Reports, then choose Generators, Irrigation, and/or Residential LM Notice. Click Options and select the contact(s) you wish to receive load control notifications.

You can also download the SmartHub app and follow these steps on your phone or tablet.

Our current load control notification system will no longer be active effective 1/1/25. Please contact our office at 320-843-4150 if you have any questions.

### ENERGY SAVINGS SCAVENGER HUNT

Saving energy at home is a great way to help the environment (and save money). With the help of an adult, look for ways you can save energy around your home. Use the tips below to get started, then check off the areas where you've identified ways to save!



#### **TASK: Bright Ideas** Ensure your home uses energysaving LED bulbs. If you find incandescent or CFL bulbs, replace them with LEDs TASK: Empty Rooms Turn off lights and ceiling fans in unoccupied rooms to conserve energy. **TASK: Sealed for Savings** Check windows to make sure they are closed and locked. Sealed windows help prevent air leaks, which saves energy. **TASK: Set to Save** Check the thermostat to see if it can be adjusted a few degrees (either lowered in winter or raised in summer) to conserve energy used for heating or cooling your home. TASK: Slay Energy Vampires Energy vampires are devices that consume energy even when they're not being used. Unplug these items, like phone chargers and tablets, when you're not using them.
