Agralite Issuing \$1.06 Million In Capital Credit Checks

Your Board of Directors has authorized the return of approximately \$1.06 million dollars in capital credits to members who purchased electricity during 2000, 2001, 2018, and 2019. For eligible active members of the cooperative, capital credits of \$20.00 or less will be issued as a credit on your May electric bill, which is sent out the first part of June. You will see this credit as a separate line item on your bill. For members where their capital credit refunds are greater than \$20.00 and current on their electric bill, a check has been issued. Whether we return it to you in the form of a bill credit or a check – you can see the value of membership!

As a cooperative, Agralite allocates capital credits each year. At the end of the fiscal year, the amount of your capital credits allocated for that year is listed on your monthly bill. Capital credits are normally retained by the cooperative for a number of years and used as operating capital. Once the Board of Directors deems appropriate, they approve the refund of these capital credits. As a perk of being a member-owner of Agralite Electric Cooperative, you get money back. After the 2024 capital credit payout this year, Agralite will have returned over \$16 million in capital credits to it members. That's the power of the cooperative membership!


Find your account number and win a \$100 credit!

Energy Scams Unmasked

Consumers with water, gas, and electricity connections have long been targets for utility scams. But in today's digital world, every swipe and click increases the risk of potential scams. Scammers are more sophisticated than ever before, and they understand our increasing reliance on technology. 538902 With their sharpened digital knives, scammers have adapted their tactics to trick unsuspecting consumers through a variety of methods. Agralite Electric Cooperative wants to help you avoid energy scams, whether a financial loss or leak of your personal information. This article shares some of the latest utility scams, as well as tips to help you stay safe from even the craftiest scammers.

Recent Utility Scams

Scammers typically disguise themselves—either physically or digitally—as utility employees or representatives to steal consumers' money or personal information. A common trick is to claim a consumer's bill is past due and threaten to disconnect service if payment isn't received immediately. Scammers approach consumers through a variety of means, including phone calls, text messages, emails, and even

in-person visits. However, the digital line of attack is increasingly more common. For example, new capabilities disguising caller ID or "spoofing" can make the phone number you see on caller ID appear to be from a trusted source. Spoofing makes it easier for scammers to deceive you because it's more difficult to immediately verify the call. Another recent scam uses fraudulent websites that are identical to a utility payment webpage—and what's worse, these pages are often promoted on search engines to trick consumers into clicking and making a payment.

Another recent scam involves phone calls, text messages, or emails claiming you overpaid your electric bill and will receive a cash or banking refund. This offer may seem too good to be true, and it is—it's likely a scam aimed to steal your personal information.

Spotting A Scam

There are several red flags you can watch for to identify an energy scam. Scammers often use high-pressure tactics to create a sense of urgency, like claiming your electricity or other services will be disconnected if a payment isn't made immediately. Additionally, scammers may ask for unusual payment methods such as gift cards or cryptocurrency. If someone is pushing for an unusual payment method, it's likely a scam. You've probably noticed that many digital scams, like emails or text messages, include poor grammar, spelling errors, and odd email addresses. These are red flags, so when you see these dodgy forms of communication, consider it a potential scam.

What Agralite Will (And Won't) Do

Agralite will never demand an instant, immediate payment and threaten to disconnect your service without prior notices or warnings. We strive to resolve challenging situations and work with our members to avoid disconnects. Agralite will never ask for your Social Security number or banking details over the phone or through email. We offer several secure payment options, including in-person, by mail, pay by phone, scheduled payments, SmartHub, and the drop box outside our office.

Avoiding Scams

Whether in-person, over the phone or online, always be suspicious of an unknown individual claiming to be an Agralite employee requesting banking or other personal information. If you're ever in doubt about a potential energy scam, just give us a quick call at 320-843-4150 so we can assist. Agralite wants to help protect you and our community against utility frauds, and by notifying us about potential scams, you can create the first line of defense. We encourage you to report any potential scams so we can spread the word and prevent others in our community from falling victim.



High-Pressure Tactics

Scammers will pressure you, creating a sense of urgency. Claims that your power will be disconnected without immediate payment are common with utility scams.

Sketchy Payment Methods

Scammers may ask for unusual payment methods like gift cards or cryptocurrency. In these cases, it's likely a scam.

Dodgy Communication

Whether an email, text message or letter, utility scams typically include poor grammar, spelling errors or unusual email addresses. These are common warning signs of a scam.

Heat Pumps Offer Benefits For Consumers And The Environment

Many companies and homeowners are looking to reduce their use of fossil fuels by looking for new ways to use electricity to help them achieve their goals. The strategy to replace direct fossil fuel use with electricity to reduce overall emissions and energy costs is called "beneficial electrification." It's made possible as utilities, including Agralite Electric Cooperative, work to continue more carbon-free sources of energy into their power supply portfolios.

Beneficial electrification available across the residential and commercial sectors, including making the switch to an electric vehicle or an electric heating system —as long as the end-user and environment both benefit from the change. One home appliance that provides the opportunity to reduce fossil fuel use and replace it with electricity is the heating system. Heat pumps have become increasingly popular as technology advances to support heating in colder climates. 1520100

Like an air conditioner, a heat pump can cool your home. What makes them unique is that they can also provide heat. Unlike other electric heating options, air source heat pumps (ASHPs) do not use electricity to create heat but instead use it to move heat from outdoor air and transfer it indoors. With today's ASHP technology, this process of moving heat is extremely energy efficient even when it's cold outside. According to Rewiring America, a nonprofit advocacy group, heat pumps can achieve more than 300% efficiency, while even the most efficient gas-powered furnaces fall short of 100% efficiency. It is common for homeowners who install an ASHP to save hundreds of dollars per year.

Agralite provides rebates for ASHPs throughout the year. Be sure to check with us prior to purchase to confirm what options are available and to ask any additional questions. A list of our current rebates is also on our website at www.agralite.coop.

The agenda, minutes of the last meeting, the monthly disbursements, and the payment of capital credits of deceased members were approved.

Jonathan Messner, Manager of Member Services, reported on activities of his department for the month. He discussed load control for the month. He discussed a previous donation to the Benson Aquatic Center. The board voted to approve the redesignation of funds to the umbrella project. He discussed the scholarship program and asked for volunteers to present at the school scholarship ceremonies.

Stephanie Wrobleski, Manager of Finance/CFO, discussed margins for the month of March. She discussed capital credit retirement options and the Board approved Option 2 and the Great River Energy capital credit payout. The checks will be mailed out the end of May.

The financials were given by Stephanie with a PowerPoint presentation.

Tom Hoffman, Manager of Engineering & Operations, reported on activities of his department for the month. He discussed line crew projects and outages for the month. He stated that Reece Larson was hired for a 1,000-hour lineman position.
