#### Advocating For A Balanced Energy Future By Jenny Stryhn, General Manager

The landmark 2040 carbon-free bill set Minnesota on an aggressive path toward eliminating carbon emissions from our energy production. Minnesota's rural electric cooperatives are working toward meeting this mandate. Going forward, we must view energy policy decisions through a risk-sensitive lens to identify and address any issues that could impact the reliability and affordability of the electricity delivered to the state's population. At Minnesota's electric cooperatives, we advocate for an "all-tech-on-deck" approach to achieving our carbon reduction goals. 991201 While wind, solar, and battery storage are vital components of our future energy mix, relying on these resources alone presents challenges—these technologies cannot always provide electricity when needed.

To meet our state's energy needs and reduce carbon emissions effectively, it's essential that we unlock the potential of all carbon-free energy sources, including nuclear power. However, Minnesota's current nuclear moratorium limits our ability to begin discussion to bring new, carbon-free nuclear energy into the mix. Currently, Minnesota is the only state with a complete ban on new nuclear energy. Minnesota Rural Electric Association is urging policymakers to lift this moratorium and explore nuclear energy as a key part of our clean energy future and stabilize the energy grid for future years to come.

Join us: June 11-13 / \$175 per person / 20 seats available



#### 2025 Agralite Scholarships

Starting in 2016, Agralite Electric Cooperative created a post-secondary education scholarship program. This program is open to the four-county region Agralite provides electric service to—Big Stone, Pope, Stevens, and Swift counties.

Agralite Electric Cooperative will award ten \$2,000 scholarships. Two of the scholarship awards are intended for individuals interested in becoming an electrical line worker or electrician. These scholarship funds were made available in part through both unclaimed capital credits and administration proceeds from The Rural Economic Development Loan program.

## COLD WEATHER RULE & ENERGY ASSISTANCE PROGRAM NOTICE

In accordance with Minnesota's Cold Weather Rule, electric service cannot be disconnected for nonpayment between October 1 and April 30 if electricity is the primary heat source and ALL of the following statements apply:

- Your household income is at or below 50% of the state median household income. Income
  may be verified on forms provided by Agralite Electric Cooperative or by the local energy
  assistance provider.
- You enter into and make reasonably timely payments under a payment agreement that considers the financial resources of the household.
- You receive referrals to energy assistance, weatherization, conservation, or other programs likely to reduce your energy bills from Agralite Electric Cooperative.

Minnesota's Cold Weather Rule does not completely stop winter disconnects

Before disconnecting electric service to residential members between October 1 and April 30, Agralite Electric Cooperative must provide:

- A 30-day notice of disconnection;
- A statement of members' rights and responsibilities;
- A list of local energy assistance providers;
- Forms on which to request Cold Weather Rule protection; and
- A statement explaining available payment plans and other options to continue service.

#### **Energy Assistance Program**

The Energy Assistance Program (EAP) is a federally funded program through the U.S. Department of Health and Human Services, which helps low-income renters and homeowners pay for home heating costs and furnace repairs. Household income must be at or below 50% of the state median income (\$58,793 for a family of four) to qualify for benefits. Applications must be received or postmarked by May 31, 2025.



# ARE YOU STORM READY?

Follow these safety and preparation tips during spring and summer storm season.

#### Be Prepared.

- Create an emergency kit with power outage essentials: batteries, powerbanks, flashlights, non-perishable foods, water, medical supplies, and prescriptions.
- Develop an emergency family plan with meeting points, communication methods, and evacuation routes.
   Share your plan with all members.
- Monitor weather for important updates that could impact your emergency plan.

#### Stay Safe.

- Ensure a safe shelter. Stay away from windows and doors. During a tornado, move to a basement or an interior room without windows.
- Use portable generators safely.
   Operate outdoors in well-ventilated areas, place on a flat, dry surface, do not overload, and always read the operating manual before use.
- Remember that severe storms can bring down power lines. If you encounter a downed line, stay back. Always assume a downed line is live and dangerous.



#### Being Ready For Storm Season Preparedness Is The Best Defense

Spring is on our doorstep and like many of you, I'm looking forward to more opportunities to be outdoors and enjoy warmer weather. Springtime brings many of my favorite activities like cooking out with family and friends, time spent working in the garden and simply slowing down a bit to enjoy life.

Unfortunately, spring and summer can also create the perfect conditions for severe storms.

Agralite Electric Cooperative crews are always prepared and standing by to respond should power outages occur in our area. When severe storms cause power disruptions, our line crews take all necessary precautions before they get to work on any downed lines.

I would encourage you to also practice safety and preparedness to protect your family during storms and outages.

The Federal Emergency Management Agency recommends the items below as a starting point for storm and disaster preparedness. Visit www.ready.gov for additional resources.

 Stock your pantry with a three-day supply of non-perishable food, including canned goods, energy bars, peanut butter, powdered milk, instant coffee, water, and other essentials (i.e., diapers and toiletries). 1282201

- Confirm that you have adequate sanitation and hygiene supplies including towelettes, soap, and hand sanitizer.
- Ensure your first aid kit is stocked with pain relievers, bandages and other medical essentials, and make sure your prescriptions are current.
- Set aside basic household items you will need including flashlights, batteries, a manual can opener, and a portable, batterypowered radio or TV.
- Organize emergency supplies so they are easily accessible in one location.

In the event of a prolonged power outage, turn off major appliances, TVs, computers, and other sensitive electronics. This will help avert damage from potential power surges and will also help prevent overloading circuits during power restoration. That said, do leave one light on so you will know when power is restored.

If you plan to use a portable generator, make sure it's rated to handle the amount of power you will need, and always review the manufacturer's instructions to operate it safely.

Listen to local news or a NOAA weather radio for storm and emergency information, and check Agralite Electric Cooperative's Facebook page for restoration updates.

Severe storms can occasionally bring down power lines. If you see a downed line, always assume it's energized and never approach it. If flooding occurs, never walk through areas where power lines could be submerged.

Advance planning for severe storms or other emergencies can reduce stress and anxiety caused by the weather event and lessen the impact of the storm's effects.

Sign up for NOAA emergency alerts and warnings and follow us on Facebook for the latest power restoration updates. If you experience an outage, please don't report it on Facebook. Call our outage reporting number at 888-884-3887—this is the fastest way to let us know if your power is out.

I hope we don't experience severe storms over the spring and summer months, but we can never predict Mother Nature's plans. At Agralite Electric Cooperative, we recommend that you make a plan today—because storm preparedness is always our best defense.

#### Director Nominations Now Open for Districts 3 & 4

Would you like to serve as a Director on the Agralite Electric Cooperative Board for your district? Agralite Electric Cooperative is governed by a seven-member Board of Directors elected by our membership. The cooperative's service territory is divided into seven districts, with each district represented by a director who resides in that district. Directors elected serve a three-year term.

This year we will have an election for directors for Districts 3 and 4.

District 3 includes the townships of: Darnen, Hodges, Horton, Moore, Walden, Blue Mounds, Hoff, and Langhei.

District 4 includes the townships of: Minnewaska, Glenwood, Barsness, Chippewa Falls, Bangor, Rolling Forks, and Gilchrist.

Any member meeting the qualifications as specified in the Bylaws of Agralite Electric Cooperative may become a candidate for election to the Board by submitting a written petition for nomination with the signatures of no less than 15 members who are residents of the district for which the election is being held. All voting will be done by mail. Ballots will be mailed to all Agralite voting members on record in these districts before the Annual Meeting. The election takes place at the Annual Meeting on June 10, 2025.

The financials were given by Stephanie with a PowerPoint presentation.


