#### Agralite Donates \$3,200 To Local Food Shelves During Minnesota FoodShare Month

Here at Agralite we are always proud of what our Operation Round Up program does for our four-county region. In March, Operation Round Up donated to all four of our local food shelves in Big Stone, Pope, Stevens, and Swift counties.

The Board of Directors at Agralite created a board policy to contribute unclaimed capital credit dollars to Agralite's Operation Round Up. A portion of those dollars go directly to our local food shelves, totaling \$3,200 for the month of March.

These dollars were delivered during Minnesota FoodShare month. During the March Campaign, donations are matched by Minnesota Food Share. The amount of matched dollars received is based on a percentage of how much was raised in the county. The more dollars raised, the more matching funds received.

If you haven't yet considered signing up for Operation Round Up, it's never too late! On average, Agralite members contribute about \$6 a year. A little goes a long way!

#### **Energy Saving Tip:**



Even in the summer months, adding insulation to your attic can keep your home more comfortable and save energy used by your cooling system.

If your attic insulation is level with or below your floor joists (meaning you can easily see your joists), you should add more. If you can't see any of the joists because the insulation is well above them, you likely have enough insulation. Attic insulation should be evenly distributed with no low spots. Make sure the areas along the eaves are adequately covered.

#### Director Nominations Now Open for Districts 3 & 4

*Would you like to serve as a Director on the Agralite Electric Cooperative Board for your district?* Agralite Electric Cooperative is governed by a seven-member Board of Directors elected by our membership. The cooperative's service territory is divided into seven districts with each district represented by a director who resides in that district. Directors elected serve a three-year term.

This year we will have an election for directors for Districts 3 and 4.

District 3 includes the townships of: Darnen, Hodges, Horton, Moore, Walden, Blue Mounds, Hoff, and Langhei.

District 4 includes the townships of: Minnewaska, Glenwood, Barsness, Chippewa Falls, Bangor, Rolling Forks, and Gilchrist.

Any member meeting the qualifications as specified in the Bylaws of Agralite Electric Cooperative may become a candidate for election to the Board by submitting a written petition for nomination with the signatures of no less than 15 members who are residents of the district for which the election is being held. All voting will be done by mail. Ballots will be mailed to all Agralite voting members on record in these districts before the Annual Meeting. The election takes place at the Annual Meeting on June 30, 2022. 1400400

### 1. Please tell Agralite Members a little bit about yourself.

#### 2. Are you active in any community activities?

Wendy and I are active in a new church plant in Hancock and I am also involved with the Republican Party of Stevens County.

#### 3. How long have you been an Agralite Member?

#### 4. Why do you want to be a Director?

#### 5. What does the role of Director mean to you?

It means learning as much as possible about the needs of our residential farms, small power and large power members, and together with the other directors work with the manager and staff to give sound direction for our cooperative.

### 6. Please characterize what you see as the role of Agralite's board?

To ask questions and to take the responsibility of being a watchdog for our members. To encourage the manager and staff, to stay abreast of what's happening amongst our power providers, to stay on top of what is happening in Saint Paul and Washington DC.

### 7. What aspects of the director's job do you consider the most crucial?

Asking questions and to encourage others that there are no dumb questions. Listening to each other (Manager, staff and directors) and together coming to decisions that keep our cooperative healthy.

### 8. What work experience or other board experience do you have that will help you be an effective Director?

I believe that my work experience as a farmer and manufacturer and caring for what happens in our communities helps me to make wise decisions that will ensure that our area is a good place to live both now and for the generations to come.

#### 9. What challenges do you see for Agralite Electric Cooperative in the future and how does the cooperative meet these challenges?

# DOES YOUR HOME NEED A CHECKUP?



To ensure your home's electrical system is safe, its wiring should be up to date and any defects corrected.

How do you know if your home needs an electrical inspection?



#### If your home was last inspected:

- 40 or more years ago, an inspection is overdue.
- 10 to 40 years ago, an inspection is advised.
- Less than 10 years ago, an inspection should not be necessary unless there are issues.

Regardless of when your home was last checked, consult a qualified electrician/licensed contractor if you notice symptoms of a potential hazard, such as dim/flickering lights, unusual sounds, a frequent need to reset fuses or breakers, overheating, odors, loose plugs, damaged insulation on wires or conditions that cause electrical shocks.

#### Manager's Article: Prioritize Safety Year-Round by Kory Johnson

At Agralite Electric Cooperative, we recognize Electrical Safety Month every May, but we also know the importance of practicing safety yearround. From our co-op crews to you, the consumer-members we serve, we recognize that everyone has a part to play in prioritizing safety.

According to the Electrical Safety Foundation International, thousands of people in the U.S. are critically injured or electrocuted as a result of electrical fires and accidents in their own homes. Many of these accidents are preventable. Electricity is a necessity, and it powers our daily lives, but we know first-hand how dangerous electricity can be because we work with it 365 days a year.

To me, safety is more than a catchphrase. As General Manager, it's

my responsibility to keep co-op employees safe. Additionally, we want to help keep you and all members of our community safe. That's why you'll see Agralite hosting safety demonstrations at community events and in schools throughout the year, to demonstrate the dangers of electricity. We discuss emergency scenarios, such as what to do in a car accident involving a utility pole and downed power lines. We caution students on the dangers of pad-mounted transformers and overloading circuits with too many electronic devices. We also have our Safety Demonstration Trailer at our local county fairs in the summer.

### Electricity is an integral part of modern life. Given the prevalence of electrical devices, tools and appliances, I'd like to pass along a few practical electrical safety tips:

- 1 Frayed wires pose a serious safety hazard. Power cords can become damaged or frayed from age, heavy use or excessive current flow through the wiring. If cords become frayed or cut, replace them, as they could cause a shock when handled.
- 2 Avoid overloading circuits. Circuits can only cope with a limited amount of electricity. Overload happens when you draw more electricity than a circuit can safely handle—by having too many devices running on one circuit.
- 3 Label circuit breakers to understand the circuits in your home. Contact a qualified electrician if your home is more than 40 years old and you need to install multiple large appliances that consume large amounts of electricity.
- 4 Use extension cords properly. Never plug an extension cord into another extension cord. If you "daisy chain" them together, it could lead to overheating, creating a potential fire hazard. Don't exceed the wattage of the cord. Doing so can overload the cord, creating a fire hazard. Extension cords should not be used as permanent solutions. If you need additional outlets, contact a licensed electrician to help.

I encourage you to talk with your kids about playing it safe and smart around electricity. Help them be aware of overhead power lines near where they play outdoors.

Our top priority is providing an uninterrupted energy supply 24/7, 365 days per year. 1348201 However, it is equally important to keep our community safe around electricity.

## Agralite issuing \$1.18 Million in Capital Credit Checks

Your Board of Directors has authorized the return of approximately \$1.18 million dollars in capital credits members who purchased to electricity during the 1990s, 1996, 1997 and 2017. For eligible active members of the cooperative, capital credits of \$20.00 or less will be issued as a credit on the April electric bill that will be mailed out the first part of May. You will see this credit as a separate line item on your bill. For members whose capital credit refunds are greater than \$20.00 and are current on the electric bill, a check has been issued. Whether we return it to vou in the form of a bill credit or a check – you can see the value of membership!

As a cooperative, Agralite allocates capital credits each year. At the end of the fiscal year, the amount of your capital credits allocated for that year is listed on your monthly bill. Capital credits are normally retained by the cooperative for a number of years and used as operating capital. Once the Board of Directors deems appropriate, they approve the refund of these capital credits. As a perk of being a member-owner of Agralite Electric Cooperative, you get money back. After the 2022 capital credit payout this year, Agralite will have returned over \$14 million in capital credits to its members. That's the power of cooperative membership! 1062900

#### MINUTES OF MEETING BOARD OF DIRECTORS March 2022

Board Chairman Orvin Gronseth called a meeting of the Board of Directors of Agralite Electric Cooperative to order at 8:30 a.m., March 31, 2022. All members of the Board were present except Director Draeger who joined by Zoom. The agenda, minutes of the last meeting, the monthly disbursements, and payment of capital credits of deceased members were approved.

Jonathan Messner, Manager of Member Services, reported on activities of his department for the month. He discussed load management and billing peaks. He discussed the Ford Lightning electric pickup truck. He stated that the Contractor Meeting has been set for April 20th at the Benson Golf Club.

Jenny Stryhn, Manager of Finance, discussed Agralite's margins for the month of February. She discussed WAPA rates. She discussed capital credits and allocations. The Board approved 2021 Capital Credit allocations, Capital Credit Payout Option 1, and GRE Capital Credit Payout. The checks will be mailed out in April. She discussed township accounts and the Board approved to start assessing a late fee penalty to these accounts that are past due, and to continue the special credit if usage is less than 1,000 kwh in a year. She discussed new Board Policy 306 Standby
